WAIVER OF NEGLIGENCE

I, _____ do hereby discharge, waive and release, and agree not to sue, Kevin Golier, Jodie Golier, CampKevin, Inc. and their directors, officers, employees, servants, and agents (hereinafter the "Releasees") from any and all liability for injury, loss, damage, obligation, expense, or penalty, including attorneys' fees, that I may sustain in connection with my attendance and participation in the Experience, July 4-7, 2024 in Brookville, Pennsylvania, *WHETHER CAUSED BY THE NEGLIGENCE OR CARELESSNESS OF THE RELEASEES, OR OTHERWISE.*
